→ Tile/Tableview

FEAT: Added functionality to search connected items and search within predefined properties of infrastructure items.

→ Data Storage

FIX: Increased size limit to 1 GB per upload

--- API

FEAT: Added an endpoint for querying Audit Log entries

FEAT: Added a streaming endpoint for changed items

FIX: Changed to a more secure hashing algorithm for API Keys (invalidates previously created API Keys)

FEAT: Consolidated Audit Logs after renaming or deleting tenants. Only the current name gets displayed in the Audit Log filters

FEAT: Master tenants that are an acuumulated readonly view over multiple tenants can be created. Supports Tile/Table/IT Service/Business/GANTT View

→ Audit Log:

FEAT: Automatic deletion can be configured in global settings

FEAT: Tenants in filter view are sorted alphabetically

FEAT: Permissions can be assigned to local roles per tenant

FIX: "Admin" role was unable to view audit logs in certain scenarios
